

# Referral Program Terms & Conditions

Updated: 21 June 2021



# 1. Duration of Promotion

The Pennytel 'Refer a Friend' promotion is available during the period of 1 October 2018 to 31 December 2021 ('Promotion Period') for Pennytel customers who:

- a) meet the eligibility criteria outlined in clause 2 below; and
- b) refer a friend who meets the eligibility criteria outlined in clause 3; and
- c) comply with the Terms and Conditions of this promotion.

# 2. Your Eligibility

To be eligible to refer a friend and participate in the promotion you must be a current Pennytel customer. Agents, including resellers, affiliates and business partners, of Pennytel and its Related Bodies Corporate (as defined in the *Corporations Act 2011 (Cth)*) are not eligible for this Promotion.

# 3. Eligible Referrals

The referred person must:

- a) not be an existing customer of Pennytel; and
- b) be referred by a person that meets the eligibility criteria in clause 2 above; and
- c) sign up to receive a Pennytel service and provide Pennytel with their referrer's mobile number during checkout either over the phone or on the Pennytel website; and
- d) have activated their Pennytel services.

Each person meeting the requirements specified in (a) to (d) above will be an 'Eligible Referral'.

## 4. Successful Referral

A referral will be a Successful Referral when the criteria outlined in clause 2 (regarding Your Eligibility) and clause 3 (Eligible Referrals) has been met in full. All Successful Referrals will be eligible to receive the Promotion Offer.

## 5. Promotion Offer

During the Promotion Period, for each Successful Referral, Pennytel will:

- a) credit \$10 to the referring person's existing Pennytel account when the referred person pays their first invoice; and
- b) credit \$10 to the referred person's Pennytel account when they activate their Pennytel service,

(the 'Promotion Offer').

Pennytel may, from time to time and in its sole discretion, replace the credits to the referring person and referred persons Pennytel accounts with a different credit amount provided always



that the amount credited to the referring and referred person's Pennytel account is no less than the credits specified in the Promotion Offer.

# 6. Other Terms and Conditions

- The Promotion Offer and Alternative Offer are not exchangeable or redeemable for cash, credit or any other gift.
- Pennytel reserves the rights to change, suspend or discontinue all or any part of this
  promotion, at its discretion. Pennytel will endeavour to, but is not obliged to, provide
  reasonable notice of any change, suspension or discontinuance by updating this page at
  least 30 days before the change, suspension or discontinuance.
- Referrer will be entitled to receive the Promotion Offer for each Successful Referral up to a maximum of 20 times for the duration of the promotion.
